

GEN 4 CHARGES FOR AERODROMES/HELIPORTS AND AIR NAVIGATION SERVICES

GEN 4.1 AERODROME/HELIPORT CHARGES

IBRAHIM NASIR INTERNATIONAL AIRPORT

1 Landing of Aircraft

Maximum permissible take-off weight allowed as specified under the regulation of the State in which the aircraft is registered.

a) International flights

<i>Aircraft weight</i> (kg)	<i>Charge per 1000 kg or part thereof</i> (US\$)
6000kg or less than 6000kgs	45.00
over 6000kgs	4.75 per 1000kg plus fixed fee US \$ 45.00

b) Domestic flights

i) Aircraft

<i>Aircraft weight</i> (kg)	<i>Charge per 1000 kg or part thereof</i> (US\$)
6000kg or less than 6000kgs	37.50
over 6000kgs	3.75 per 1000kg plus fixed fee US \$ 37.50

ii) Seaplane:

<i>Aircraft weight</i> (kg)	<i>Charge per 1000 kg or part thereof</i> (US\$)
less than 6000kgs	15.00 per landing

iii) Helicopter

All helicopter operators are levied US\$ 1.00 per seat for each landing.

2 Parking, hangar age and long-term storage of aircraft

2.1 *Parking of aircraft*

First three hours are free. The charges payable for the use of the apron in excess of three hours shall be;

- a) International and Domestic flights - scheduled, charter and cargo flights:
20% of landing fee for every three hours or part thereof with minimum us \$ 250.00
- b) International ADHOC flights that have MTOW below 70 tons:
50% of landing fee for every three hours or part thereof, subject to a minimum US \$ 1000.00
- c) International ADHOC flights that have MTOW 70 tons or more:
30% of landing fee for every three hours or part thereof, subject to a minimum US \$1000.00

2.2 **Hangar age charges**

Not applicable as no hangar space is normally available for visiting aircraft.

2.3 **Long-term storage**

3 **Passenger Service**

Each foreign passenger departing for a foreign country at an international airport is charged US\$ 12.00 and each local passenger departing for a foreign destination at an international airport will be charged the current equivalent of US\$ 12.00 in Maldivian Rufiyaa.

7.5 **Surcharges**

A surcharge of 10% will be collected on every landing or take off between 0800 hours to 1400 hours local time for all MACL Ltd. administered aerodromes except where it is stated to the contrary.

Unless an alternative arrangement has been made, all charges for use of the aerodrome are payable

by the pilot of the aircraft on demand or before the aircraft departs from the aerodrome.

8 **Methods of payment**

8.1 **Landing Charge**

Landing charges are payable at the time of using the aerodrome or in the case of approved regular users, as per prior arrangement for extension of credit made between Maldives Airports Company Ltd and the user.

8.2 **Passenger Service Charge and Insurance Surcharge**

Passenger Service Charge and Insurance Surcharge shall be collected by Carrier at point of sale of passenger ticket and shall be shown separately on passenger ticket under code BQ. Passenger charges collected are payable to Maldives Airports Company Limited by Carrier at time of departure, or in case of approved regular users, as per prior arrangement for extension of credit made between Maldives Airports Company Limited and the user.

8.3 **Parking Charge**

Parking charges are payable at the time of using the apron, or in the case of approved regular users as per prior arrangement for extension of credit made between Maldives Airports Company Ltd and the user.

Parking charges will be calculated for blocks of three hours. Parking hours start from 'step on' time and ends at 'door close' time.

over 6000kgs	3.75 per 1000kg plus fixed fee US \$ 30.00

ii) Helicopter

All helicopter operators are levied US\$1.00 per each landing.

3 Parking, hangar age and long-term storage of aircraft**2.4 Parking of aircraft**

First three hours are free. The charges payable for the use of the apron in excess of three hours shall be;

- a) International and Domestic flights - scheduled, charter and cargo flights:
10% of landing fee for every three hours or part thereof with minimum charge of US\$ 50.00
- b) International ADHOC flights:
10% of the landing fee for every three hours or part thereof with a minimum US \$50.00

Each passenger departing from an airport in the Republic of Maldives to a foreign destination shall pay a charge as Airport service charge as follows;

- Passenger Tax: (Foreign Nationals) USD 18.50
- Passenger Tax: (Maldivian Nationals) USD 12.00

Total US\$ 18.50 per departing International Passenger of two years of age and over

8.5 **Passenger Service Charge and Insurance Surcharge**

Passenger Service Charge and Insurance Surcharge shall be collected by Carrier at point of sale of passenger ticket and shall be shown separately on passenger ticket under code BQ. Passenger charges collected are payable to Addu International Airport Pvt Ltd by Carrier at time of departure, or in case of approved regular users, as per prior arrangement for extension of credit made between Addu International Airport Pvt Ltd and the user.

8.6 **Parking Charge**

Parking charges are payable at the time of using the apron, or in the case of approved regular users as per prior arrangement for extension of credit made between Addu International Airport Pvt Ltd and the user.

Parking charge will be calculated for every three hour blocks.

Parking hours starts from the time of arrival of the aircraft and ends at the time of departure.

2. Parking, hangar age and long-term storage of aircraft

2.1 *Parking of aircraft*

First three hours are free. The charges payable for the use of the apron in excess of three hours shall be;

- Scheduled, charter, cargo and Ad-hoc flights
20% of landing fee for every three hours or part thereof with minimum charge of US\$ 50.00

2.2 *Hangarage charges*

- a) Scheduled, chartered and cargo flights

40% of landing fee for every 3 hours or part thereof with minimum of US\$500.00

- b) Ad-hoc flight

Landing fee for every 3 hours or part thereof with minimum of US\$1600.00

8.3 **Parking Charge**

Parking charges are payable at Villa Air Pvt Ltd and the user.

Parking charge will be calculated for every three hour blocks.

Parking hours calculated between the aircraft first "Chocks On" time to the last "Chocks Off" time for the same return flight.

Note: GST (Goods and Services Tax) applies 8% to all charges.
